In attendance: Christopher, Naila, Valdr, Alexina, Richard, Mary, Caitilin, Alysa, Serena, Harald, Ceridwen


Business Meetings are held on the first Tuesday of each month, 7:00pm at Big Larry's Comic Book Cafe, Leonardtown, MD 20650.

Knight Marshal's Report


No report. Seneschal will speak to him to see if he wishes to continue; if he wishes to be replaced, there is a volunteer.




Original leaves from medieval manuscripts




